Chrysler Group LLC brings back 'Minivan Month' for April

April 5, 2011, Auburn Hills, Mich. - Chrysler Group LLC announced today it is bringing back the 60-day "Minivan Pledge" to launch Minivan Month.

The pledge allows consumers purchasing a new 2011 Chrysler Town & Country or Dodge Grand Caravan minivan during April to return the vehicle, no questions asked, within 60 days. In addition to the pledge, consumers can choose \$750 in Customer Cash or attractive financing as low as 2.9 percent for 60 months.

An additional \$750 in Bonus Cash is available for consumers who purchase the Chrysler Town & Country. Consumers who purchase the Dodge Grand Caravan also are eligible for up to \$1,500 in Trade-In Bonus Cash. In addition, current Grand Caravan owners are eligible for \$1,000 in Owner Loyalty Cash.

The Chrysler Town & Country was the best-selling minivan in the United States during 2010. Both the Chrysler Town & Country and the Dodge Grand Caravan minivans topped 100,000 units in 2010, returning Chrysler Group to dominance in the segment it established. The Dodge Grand Caravan is America's best-selling minivan ever.

Chrysler Brand

Consumers who purchase a 2011 Chrysler 200 Convertible are eligible for \$750 Consumer Cash or attractive financing as low as 0 percent for 36 months, up to 3.9 percent for 72 months. Consumers also are eligible for an additional \$750 in Bonus Cash.

Attractive lease rates are available on the 2011 Chrysler 200 sedan and convertible, and the 2011 Chrysler Town & Country.

Jeep® Brand

Consumers who purchase the 2011 Jeep Liberty are eligible for up to \$3,000 in Consumer Cash or attractive financing as low as 0 percent for 60 months.

In celebration of the Jeep brand's 70th Anniversary, the Mopar brand announced today \$500 Mopar Bucks for 2011 Jeep Wrangler accessories. Consumers who purchase a 2011 Wrangler in April are eligible for \$500 worth of Jeep accessories.

Attractive lease rates are available on the 2011 Jeep Compass, Patriot, Liberty and Grand Cherokee.

Dodge Brand

Consumers who purchase a 2011 Dodge Journey are eligible for \$750 in Consumer Cash, and up to \$1,750 Consumer Cash on the Crew and Lux models, or attractive financing as low as 1.9 percent for 60 months.

Consumers who purchase a 2011 Dodge Durango RWD are eligible for \$1,000 Consumer Cash or attractive

financing as low as 1.9 percent for 60 months.

Attractive lease rates are available on most 2011 Dodge models.

Ram Truck

Consumers who purchase a 2011 Ram 1500, 2500 or 3500 pickup are eligible for \$1,000 in Trade-In Cash or attractive financing rates.

Consumers who purchase a Ram 1500 Crew Cab are eligible for \$500 Ram Box Bonus Cash.
